TERMS AND CONDITIONS:

- + Offers expire 30 days from the date presented.
- + Full Yacht Fee is required to secure the specific date desired.
- + Payment in full is due 14 days prior to charter.
- + Signed 'Manhattan Steamboat Charter Agreement' between Manhattan Steamboat Company, LLC and the client is required to secure charter.
- + All charters are subject to time and availability.
- + Vessel sails rain or shine, except in severe weather conditions (such as hurricane strength winds or river freezing).
- + Boarding 15 minutes prior to charter (30 min Wedding Ceremony Cruises).
- + Disembarkation within 15 minutes after completion of charter (30 min Wedding Ceremony cruises).
- + Afternoon charters, including disembarkation, must be completed by 4:00 p.m.
- + Smoking is not permitted in interior cabins.
- + No Alcoholic Shots are served on board.
- + No Alcoholic Drinks are served to Vendors.
- + Should the charterer cancel, all monies paid will be forfeited.
- + Gratuities are not included but are customary (suggested Gratuities: \$300-500).
- + Pricing reflects a discount for check/money order/wire transfer payments only. Credit Card payments will incur additional 3% facility processing fee.
